## **Contract Grazing Services**

The following are goat or sheep herders who hire out their herds for brush and invasive plant species management. Controlled grazing is not suited for many projects. Some things to consider: Mowing is likely a better tool if the terrain allows it. Projects less than five acres are better suited for hand work. A single grazing event is ineffective, so follow-up grazing is necessary. Although animals are often insured, urban and suburban areas are often not an option for grazing. Appointments, with a few exceptions, must be made in upwards of a year in advance.
